Settlement for Acquisition of Yandal South Gold Project

Further to the announcement on 17 January 2018, Draig Resources Limited (ASX:DRG) ("Draig") is pleased to advise that it has completed the acquisition of the highly prospective and under explored Yandal South Gold Project.

The Yandal South Gold Project (557km²) is located between Echo Resources (ASX:EAR) Bronzewing Project and gold processing plant as well as Red 5's (ASX:RED) Darlot Gold Project and gold processing plant and is only 40 kilometres to the east of Draig's Bellevue Gold Project.

The Company has paid \$100,000 and issued 3,000,000 ordinary shares in accordance with the acquisition terms announced on 17 January 2018.

Draig has issued these shares without disclosure to investors under section 708A(5) of the *Corporations Act 2001* (Cth) ("Corporations Act").

With reference to the shares issued, in accordance with section 708A(6) of the Corporations Act, the Company gives notice under paragraph 708A(5)(e) that:
