Highlights

- Former Northern Star (ASX:NST) mine manager Mr Craig Jones has been appointed Chief Operating Officer (COO) of Bellevue Gold Ltd.
- Mr Jones was the former general manager of Northern Star’s Paulsens and Plutonic underground gold mines in Western Australia. In addition, Mr Jones held key roles within the business development team contributing to the successful acquisitions of the Barrick and Newmont assets.
- The COO appointment will drive development and potentially production at the high-grade Bellevue Gold Project which has a current Inferred Resource of 1.8 Million ounces at 11.1 g/t gold.
- Drilling continues with eight rigs contributing to the recently discovered bonanza grades at the Deacon and Mavis lodes which are expected to add further significant resource growth and higher category resources in 2020.
