Bellevue Gold Limited (ASX: BGL) is pleased to advise that it has appointed highly experienced resources analyst and investor relations executive Luke Gleeson as Head of Corporate Development.

Mr Gleeson was previously Head of Investor Relations and a Business Development officer with ASX-listed gold producer Northern Star Resources (ASX: NST) for five years.

During this time, he was heavily involved in Northern Star's successful program of asset acquisitions. As part of this process, he played a key role in securing substantial equity funding and communicating the transactions to the global analyst and investment community.

Bellevue Managing Director Steve Parsons said Mr Gleeson's skills and experience would be invaluable as the Company embarked on the next phase of its strategy to become a significant WA gold producer.

"Our rapid exploration success at the Bellevue Gold Mine means we are now closing in on a maiden Indicated Resource which should put us firmly on the path to development and production," Mr Parsons said.

Mr Gleeson's appointment follows the appointment in December 2019 of Craig Jones as Bellevue's Chief Operating Officer.

Mr Jones, who is a mining engineer, spent seven years with Northern Star, during which time he was General Manager of the Paulsen's and Plutonic gold mines in WA.
