## ISSUE OF PERFORMANCE RIGHTS, APPENDIX 2A AND APPENDIX 3G AND CLEANSING NOTICE

Bellevue Gold Limited (ASX: BGL) (Bellevue Gold) advises that it has issued 10,084,798 Performance Rights to key management personnel (KMP) under the Company's Employee Incentive Plan that was approved by shareholders on 5 November 2019 and represents 1.48% of issued capital (undiluted). This is to align their interests to that of the Company's shareholders and assist as an effective means of retaining key staff as the Company moves into an important growth phase from its flagship project, the Bellevue Gold Project.

The Company has been strongly focused on building an executive management team with the skills, experience and commitment to propel Bellevue Gold to the next level with the ultimate goal of becoming a significant Western Australian gold producer. This includes two recent KMP appointments being the Chief Operating Officer, Mr Craig Jones and Head of Corporate Development, Mr Luke Gleeson. Both appointments bring a specific skill set and level of experience gained from gold industry peers which will greatly assist Bellevue Gold achieve its goals and increase shareholder value, noting also they are also the recipients of the majority of the Performance Rights.

In order to attract and retain our new and current high calibre staff, the Board spends considerable time focussing on the long term incentive rights framework, in particular ensuring the performance hurdles relate to Company and shareholder value accretion including significant resource and reserve growth, positive studies, exploration success, share price appreciation and retention.

### *Vesting of Performance Rights*

Bellevue Gold also confirms that 3,650,000 Performance Rights that were issued to Key Management Personnel and employees in April 2018 have vested (performance conditions have been satisfied) which has resulted in the equivalent number of shares being issued. Most of these Performance Rights related to retention of KMP and were issued before the Company declared its maiden Resource in August 2018 at the Bellevue Gold Project. Bellevue remains on track for a maiden Indicated Resource in the June quarter 2020 (current Inferred Resource is 2.2Moz at 11.3g/t gold)<sup>1</sup>.

### *Cancellation of Performance Rights*

The Company also notes that 50,000 Performance Rights that were also issued in April 2018 have lapsed as the performance conditions were not satisfied.
