EXERCISE OF OPTIONS AND PERFORMANCE RIGHTS: CLEANSING NOTICE AND APPENDIX 2A

Bellevue Gold Limited (ASX: BGL) ("**Bellevue**" or the "**Company**") advises that 10,000,000 unquoted options have been exercised at a price of \$0.10 per option, resulting in proceeds of \$1,000,000.
